Social sciences and Humanities Research—European Joint Programme on Rare Diseases (EJP RD) Call for Proposals 2021 Opens: December 2020; Deadline: February 2021

This call aims to build an effective transnational research collaboration with a clear future benefit for patients. Proposals must cover at least one of the following areas:

- Health & social care services research to improve patient and familial/household health outcomes
- **Economic Impact of Rare diseases**
- Psychological and Social Impact of Rare diseases
- Impact/burden of the delay in diagnosis and of the lack of therapeutic intervention.
- e-Health in rare diseases: Use of innovative technology systems for care practices in health and social services
- Development and enhancement of health outcomes research methods in rare diseases
- Effects of pandemic crisis and the global outbreak alert and response on the rare disease field.

Please also check the <u>full list</u> of <u>excluded/ineligible</u> topics before deciding to apply. Consortia submitting a proposal must involve at least 3 PI partners from at least 3 different countries participating in Call JTC 2021. No more than two eligible partners from the same country can be present in each consortium, and further national limits may apply. The participating countries have not yet been announced.

Little Princess Trust Innovation

Deadline: 26 November 2020

Funding of £500k-1M is available to support a single project addressing a key question in paediatric cancer therapy. Applications are invited for innovative studies that explore new approaches to treatment, in particular:

- More effective treatments with fewer side effects for the patient while on treatment.
- More effective treatments resulting in improved survival rates.
- Approaches to treatment that may lead to a reduction in short and long-term sequelae of treatment (specifically how improved treatments might lead to a reduction in late effects, rather than interventions targeting specific late effects posttreatment).

The Trust generally funds basic science (with a clear plan for translation/patient benefit), translational and clinical research.
