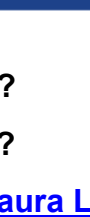

All research funding applications **MUST** be [registered with R&D](#) at least **15 days before the funder deadline** to get costings and approvals in time for the funders deadline.

UK Research and Innovation

Funding available: £5mil for the scheme

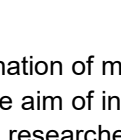
Duration of funding: up to 5 years

Eligibility: The BBSRC has launched a call for Strategic Longer and Larger (sLoLa) grants for 2022/23, with a focus on frontier bioscience. Proposals can use innovative approaches, methods or technologies to produce a significant and distinctive contribution to bioscience knowledge, typically taking a multidisciplinary approach. All applicants intending to register for this call must complete a short UCL [expression of interest form](#) and submit this along with their CV to lms.facilitators@ucl.ac.uk

[MRC Surveillance and diagnostics for antimicrobial resistance](#)

Funder deadline: 14/06/22

Funding available: The full cost of your project can be up to €50,000. MRC will fund 80% of the cost



Medical Research Council

Duration of funding: 12-24 months

Eligibility: Apply for funding to develop networks to improve diagnostic and surveillance tools for antimicrobial resistance. Your networks must include relevant experts and stakeholders. You should be based at a research organisation eligible for MRC funding or apply as part of a consortium of transnational partners.

Funding available: up to £30,000



Medical Research Foundation

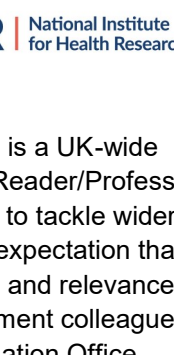
Duration: Flexible but usually 12 months

Eligibility: The aim of this award is to support the dissemination of medical research beyond the scientific peer reviewed press, with the aim of influencing healthcare and behaviour. Applications are welcomed from researchers whose findings have the potential to inform and influence healthcare policy or practice, improve patient care, or to change patient and public behaviour and opinion. All areas of medical research will be considered in this funding competition and applications can focus on any specific target group outside of the scientific press

[Anatomical Society Symington Bequest Fund](#)

Funder deadline: 28/06/22

Funding available: £500



Eligibility: The Symington Bequest Fund awards grants to society members to be used towards general costs associated with anatomical research eg costs associated with presenting and participating in scientific meetings. There are six application rounds per year. Applicants must be members who have been elected to membership by Council for at least a year by the application deadline date.

[NIHR Population Health Career Scientist Award](#)

Funder deadline: 30/06/22 1pm

Funding available: will provide funding to cover salary and research expenses



National Institute for Health Research

Duration: 5 years full time equivalent

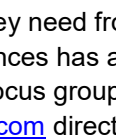
Eligibility: The NIHR Population Health Career Scientist Award is a UK-wide initiative to enable senior researchers to make the next step to Reader/Professor level in their host institutions. In growing recognition of the need to tackle wider preventable risk factors and determinants of health, there is an expectation that the research supported through this award will be of importance and relevance to local government, ideally with explicit support from local government colleagues. Applicants will get support from their relevant Research Coordination Office (LMS, BEAMS or SLASH), and UCL Health of the Public can support researchers to develop links with local authorities and UCL's population health research expertise.

Funding available: £90,000

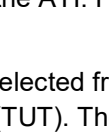

[RCR Kodak Fellowships](#)

Funding available: £65,000 per year

Eligibility: Royal College of Radiologists members of the Kodak Fellowships, funded by Kodak Ltd, to support UK members of the RCR undertaking a research project, in the UK or abroad, to further interest in an aspect of clinical radiology. Application is open to Fellows of the Faculty of Clinical Radiology holding appointments of any grade in the UK.

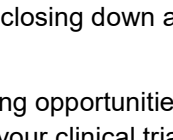
