Thank you for your request for information processed under the Freedom of Information Act 2000. Please see our response to your following request for information:

Your Request

I am looking for the original picture issued by Great Ormond Street Children's Hospital showing a CAT scan of the head of a 23 month-old toddler who was injured in the nail bomb explosion in Brixton. It shows a 4 inch nail embedded in his brain and the picture was widely disseminated in the media and used by The Metropolitan Police following the attack. We are hoping to license this image for use within the documentary and I have attached a copy of the image to this request.

Our Request

Great Ormond Street Hospital for Children NHS Foundation Trust (the 'Trust') is a single site, specialist tertiary paediatric trust. The information you are requesting is the original scan belonging to a former GOSH patient; which is their own personal data and would therefore be held in their medical record. Even though an image of the scan was previously released into the public domain does not mean the original scan can be disclosed under the provisions of the Freedom of Information Act (FOIA) 2000. Your request is therefore exempt information under Section 40(2)(Personal Information) of the FOIA. This is an 'absolute' exemption where a public authority (the "Trust") has no obligation to consider the public interest on whether to disclose the information requested.

Please note: A request for personal information relating to a third party individual falls within the provisions of the Data Protection Act (DPA) 2018. An individual requesting their own personal data would be required to submit a Subject Access Request (SAR) to the Trust's Health Records team for processing in accordance with the first data protection principles of the DPA; or where a patient is deceased would be made via an Access to Health Records (AHR) request to someone with a claim arising from the individual's death. These requests would be handled by the Trust's Health Records team in the first instance.

Please note:

The information we have provided under the Freedom of Information Act 2000 is the information held on the date your request was received by the Trust.
