DRAFT Horizon Europe Work Programme 2021-22-

UCL ERIO shared the preliminary draft Health work programme for Horizon Europe 2021-2022 (see the draft in

email distributed). The final document is expected in March/April with first call deadlines in October 2021. A big change is that proposals now need to be 45 pages long and not 70.

Chan Zuckerberg Initiative Call on Paediatric Net-

works for the Human Cell Atlas

Deadline: 30 March 2021

The Human Cell Atlas (HCA) is a global, scientist-led collaboration to map and characterise all cells in the healthy human body as a resource for scientific studies of health and disease.

This call seeks to support collaborative teams of researchers to contribute healthy, single-cell reference data from paediatric tissue samples to the HCA. Proposed projects should be three years in duration and teams should consist of at least three and up to 10 PIs, including at least one computational biologist or data scientist, one paediatrician actively engaged in clinical care, and one expert in single-cell biology.

nology and al Sciences BBSRC Discovery Fellowships

Biological Sciences
Research Council

Deadline: 6 May 2021

Up to £500,000 for 3 years to support early career researchers to undertake independent research within any BBSRC remit and gain leadership skills. Applicants should have a PhD or be expecting to have undergone successful PhD viva prior to 30 November 2021. There is no limit on the number of years of postdoc experience. However, applicants should not hold, or have held, an academic position of lecturer level or an equivalent competitive fellowship.

ERC Calls—Provisional dates announced

"Notice for UK participants: The Withdrawal Agreement foresees that the UK will continue to participate in the current 2014-2020 EU programmes, including ERC Grants, as if the UK was an EU Member State until the closure of the programmes. This means that UK beneficiaries can continue to take part in grants awarded under the current MFF until their end date, even if it is after 2020."

Starting Grant—24 March 2021 (tbc)

Funding of up to € 1.5 million for a period of 5 years for early career researchers with 2-7 years of experience since completion of PhD.

Consolidator Grant—20 April 2021 (tbc)

Funding of up to € 2 million for a period of 5 years for independent researchers with 7-12 years of experience since completion of PhD. Advanced Grant – 31 August 2021 (tbc)

Funding of up to € 2.5 million for 5 years for established researchers with a track-record of significant achievements in the last 10 years.

GOSH BRC Junior Faculty Conference and Training Support Fund—Rolling call

This fund supports researchers across GOSH and ICH to apply for funding to support fees associated with attendance at virtual conferences or virtual training opportunities of a similar scope to attending a conference. Priority will be given to junior researchers working in translational research. This is a rolling call with applications assessed once a month.
