Please note that all research funding applications must be registered with R&D at least 15 days before the funder deadline to get costings and approvals in time for the deadline.



International collaboration to address antimicrobial resistance

Funder Deadline: 08 March 2022 (4pm) Internal R&I Deadline: 15 February

Apply for funding to develop or improve drugs or plant protection agents to help:

- treat bacterial or fungal infections
- reduce the spread of resistance to drugs.

Maximum award of £250,000.

Standard MRC eligibility applies.

You should be based at a research organisation eligible for MRC funding. You must apply as part of a consortium of transnational partners.

HRA Now: Webinars for combined review

When: December 2021

Combined review comes into effect for all Clinical Trials of Investigational Medicinal Products (CTIMPs) from 1 January 2022. Combined review is where a single application for both Clinical Trial Authorisation and Research Ethics Committee (REC) opinion is made. From January 2022 it will be the only way to submit CTIMPs to MHRA and REC. Applications are completed and submitted in a new part of IRAS.

To support this change, the HRA are running a series of free, live webinars during December and January. They are designed for different user groups involved in CTIMPs and will provide an overview of upcoming changes. The webinars will be recorded and a version will be made available for anyone who cannot attend a live session.

Applicants should clearly define and justify their choice of patient group (including the specific age range), study design and outcome measures, and explain how the research will fit into the remit of the HTA Programme.



LMS Research Capital Equipment Fund Call (CEF4)

Funder Deadline: 18 January (5pm) Internal R&I Deadline: 28 December

This funding is intended to support purchase of strategically important research capital equipment. We expect many of the successful applications to be for major equipment that will be managed within multi-user facilities such as the UCL Science Technology Platforms or within other existing Core Facilities.

Applications are expected to be in excess of £50k.

Awards will support equipment purchase, installation, shipping and standard warranties. Ineligible costs include (but are not limited to) extended warranties, training, consumables, maintenance contracts and estates costs. All equipment purchased through CEF4 must be on site no later than 31 July 2022. Any equipment delivered after this date may risk having its CEF4 support withdrawn.
