Funder Deadline: 12 January 2022

Awarding five outstanding early-career women scientists a grant of £15,000 to support their research in the fields of Physical Sciences, Engineering, Mathematics and Computer Science, Life Sciences and Sustainable Development.

The awards have been designed to provide flexible and practical financial support to enable these women scientists to further their research and careers, including training and networking opportunities supported by L'Oréal. Cell and oligonucleotide therapy fellowship with AstraZeneca Funder Deadline: 8 March 2022

Apply for a fellowship to explore your own research ideas and develop links with industry, including secondments, training and mentorship. Your research project should support the development of cell and oligonucleotide therapies. This opportunity is open to both clinical and non-clinical researchers.

You should be in the early stage of your postdoctoral career. The full economic cost of your fellowship can be up to £500,000. You will be

funded for three years.



National Centre for Medical Rehabilitation Research (NCMRR) Early Career Research (ECR) Award Funder Deadline: 30 March 2022

This call is intended to support both basic and clinical research from rehabili-

tation scientists who are establishing independent research careers. The research must be focused on one or more of the areas within the biomedical and behavioural mission of NCMRR. The grant mechanism supports different types of projects including second-

ment of research methodology; translational research; outcomes research; and development of new technology. The combined budget for direct costs for the entire project period may not exceed \$200,000. No more than \$100,000 in direct costs may be requested in

any single year. The maximum period of support is two years.

NIHR Research for Patient Benefit Programme

The NIHR Research for Patient Benefit (RfPB) programme is inviting applications for research proposals that are concerned with the day-to-day practice of health

service staff, and that have the potential to have an impact on the health or wellbeing of patients and users of the NHS. The programme aims to fund high quality quantitative and qualitative research with a clear trajectory to patient benefit. It particularly encourages applications that have a strong element of interaction with patients and the public and that have been conceived in association with a relevant group of service users.



Capital Equipment Fund Call (CEF4) for researchers in the faculties of **Life and Medical Sciences**

Funder Deadline: 18 January 2022

This funding is intended to support purchase of strategically important research capital equipment. We expect many of the successful applications to be for major equipment that will be managed within multi-user facilities such as the UCL Science Technology Platforms or within other existing core Applications are expected to be in excess of £50k. Awards will support

equipment purchase, installation, shipping and standard warranties. Ineligible costs include (but are not limited to) extended warranties, training, consumables, service/maintenance contracts, staff and estates costs.

NPF Psoriatic Disease Research Fellowships Funder Deadline: 21 January 2022

The National Psoriasis Foundation (NPF) is a non-profit U.S. based organisation founded in 1966. Its mission is to drive efforts to cure psoriatic disease and improve the lives of those affected.

The NPF Psoriatic Disease Research Fellowships provide support to eligible institutions to develop and enhance the opportunities for physicians training for research careers in dermatology, rheumatology, paediatric dermatology, and paediatric rheumatology. Priority consideration will be given to applications that advance psoriatic disease research.

The grant amounts to up to \$50,000 to support their fellowship stipend. The maximum duration is one year.



Developmental pathway funding scheme Funder Deadline: 23 March 2022

Apply for funding to develop and test novel therapeutics, medical devices, diagnostics and other interventions. Your project should focus on at least one of the following stages of development:

- early development and design pre-clinical testing
- early-phase clinical studies and trials (up to phase 2a).

There's no limit on the amount of funding you can apply for. This is an ongoing scheme with a budget of approximately £30 million a Application rounds open three times a year, in February, June and October.
