

What documents do we need to see?

You must use route 1 in the 1<sup>st</sup> instance

## **Route One**

# 3 documents must be seen

One document from Group 1 plus any two from Groups 1 or 2a or 2b one of which must verify their current address.

#### **Route Two**

# (Only if the applicant cannot

produce a group 1 document) Certified copy of UK birth Cert. 4 further documents from Group 2 comprising of: 1 document from Group 2a; and 3 further documents from Group 2a or 2b; one of which must verify their current address.

# **Route Three**

### (Only after you have exhausted the route 1 & 2) 1 document from group 2a and 2 further documents from group 2a &2b +external ID validation

Please Note – If you have changed your name, please provide proof of this with either a Birth / Marriage / Deed Poll Certificate.
