Your Request

I would like to know how many health care professionals, solely nurses and ODP's (operational department practitioners) have been employed to work at Gosh operating theatres on a year by year basis starting from January 1st 2017 to current date, subheading male and female.

Lastly I would like to know how many people have left (resigned) from Gosh Operating theatres from January 1st 2017 to current date. Again this is in relation to nurses and ODP's.

Could this please be categorized in a year by years basis into 1) gender 2) length of service in Gosh theatres in years/month/days and 3) in a separate section if they had completed an exit interview with yes or no.
