Thank you for your request for information processed under the Freedom of Information Act 2000. Please see our response to your request below:

Your Request

I would like a copy of your infection control policy and your patient safety / safe guarding policy please.

Our Request for Clarification

Please can you define more specifically what you mean by an 'infection control policy' and what information it should contain?

Your Response to Our Request for Clarification

My request is to find out what you understand by it and not what I think it should be. Please can you liaise with staff who understand or wrote the policy to respond in a more appropriate fashion.

Our Further Request for Clarification

We carried out a preliminary search of the information requested where information was identified relating to infection control; but not specifically titled 'Infection Control Policy'. Do you mean i.e. the Infection Control Assurance Framework?

In respect of the information requested on patient safety, again, we do not hold a specific document titled 'Patient Safety Policy' as the information may be held under a different title or heading. Can you specify whether there are any particular aspects of patient safety that you are interested in?

Your Response to Our Further Request for Clarification

I would like any information you have of what measures you have in place to protect the children that go into Gosh from infections, accidents etc. There must be policies in place to safe guard the children that are treated in gosh. For example, what measures are in place to protect immune compromised children from picking up deadly infections whilst in hospital.

Our Response

Great Ormond Street Hospital for Children NHS Foundation Trust (the 'Trust') is a single site, specialist tertiary paediatric trust. We have obtained advice and assistance from the specialist teams on safeguarding children from infections and what measures we have in place to protect patients from cross-infections.

The Trust has a 'Standard and Isolation Precautions Policy' with aims and objectives outlined on 'when and how' to apply the following precautions:

- <u>Standard Precautions</u>: precautions applied at all times and aimed at protecting HCWs from the risk of exposure to infection through blood and body fluids.
- <u>Isolation Precautions:</u> additional precautions applied after risk assessment aimed at the prevention of transmission of microorganisms from suspected or known sources to patients and/or staff and visitors.

Please see attached copy of our 'Standard and Isolation Precautions Policy'.
