Thank you for your request for information processed under the Freedom of Information Act 2000. Please see our response to your request below:

Your Request

- 1. Could you kindly provide me with any documentation or communications that shed light on the decision not to re-submit the proposal to REC1 but instead to submit it to REC2? (eg did the researchers appeal the decision?) REC1 communicated their unfavourable opinion to the Institute of Child Health on 6 September 2010 and the Institute re-submitted its research proposal on 4 November 2010, so any search for emails would only need to cover the brief period of time between these two dates.
- 2. Could you please share with me a copy of the covering letter sent with the revised proposal in November 2010, that explains how the researchers had taken the concerns of REC1 into account?
- 3. The research study was designed to last for 6 years and an interim report would be produced at the halfway point. But in or around 2014, the study was extended indefinitely. Could you please share with me any data that would clinically justify the decision to extend the trial? REC Standard Operating Procedures state that there is no need to seek the REC's approval for a time extension but "annual progress reports should continue to be submitted... giving reasons for the extra time needed to complete the research."

It is necessary for RECs to be kept informed of the progress of research they have approved, via an annual progress report. Would you kindly share with me these annual progress reports?

Our Response

Great Ormond Street Hospital for Children NHS Foundation Trust (the 'Trust') did not take part in this study. UCL's Institute of Child Heath (ICH) was the organisation responsible for the conduct and management of this research study.
