Thank you for this response. I understood there was also a communications consultant engaged on this work, can that cost and procurement process be included in this re raised enquiry? Seeking to understand the true cost of the case for the organisation and how much public money was spent. I believe a cost is excluded for a consultant Nayler and would request that this be revisited.

Our Request for Clarification

Your request makes specific reference to a consultant named 'Nayler'. We have been unable to identify a consultant named 'Nayler' employed to carry out work on the Phase 4 scheme.

Please can you provide further details relating to the consultancy referenced in your request, which upon receipt, we can proceed further with your request for information.

Your Response to Our Request for Clarification

You responded to confirm a spelling error in the consultant's name and should have been Naylor.

Our Response

Great Ormond Street Hospital for Children NHS Foundation Trust did not employ the named consultant (as clarified) to carry out work on the Phase 4 scheme. Our final response (FOIRQ5434) is therefore the total costs you specifically requested for the Phase 4 scheme.
