Your Request

Thank you for your response to my FOI request.

In the response, you stated that "the Drug & Therapeutics Committee (DTC) made the decision that regular use of these drops is preferential, if they are without preservative". I request that you please provide a clarification on the reasons for this decision, preferably by providing me with a copy of minutes from the DTC's meetings where the use of mercaptamine/cysteamine eye drops were discussed.

Your Request

In the response, you stated that "the Drug & Therapeutics Committee (DTC) made the decision that regular use of these drops is preferential, if they are without preservative". I request that you please provide a clarification on the reasons for this decision, preferably by providing me with a copy of minutes from the DTC's meetings where the use of mercaptamine/cysteamine eye drops were discussed.

Our Response

Great Ormond Street Hospital for Children NHS Foundation Trust was already using Mercaptamine eye drops prior to the licensed product, which has been used for many years and formally approved. When the licensed product came to the market, there was no formal submission to DTC for the new product; because, at that time, the clinicians preferred to stick with a preservative free product (for an eye drop being used regularly and long term).

Whilst DTC were happy with the decision not to submit for a new product there are no formal minutes; because there was no new submission actually on the agenda. The Trust therefore continued using the original unlicensed product. However, we are aware that NHSE are due to review the commissioning of these products and will have to wait and see whether the review will inform of any change in practice.
