GOSH Charity/Wellcome Sanger Institute Partnership Grants

Deadline: 2 April 2020

Applications to pump-prime collaborative projects which aim to use single-cell transcriptomics to understand the aetiology, development or mechanism of rare disease in children with the long-term aim of improving the prevention, diagnosis, prognosis, or treatment of rare disease.

Applicants can request up to £50,000 for materials and consumables, access charges and travel between the institutes, for ~2 years.

Deadline: 20 March 2020

- Three types of fellowships are currently open:
- 1) "Entry" clinical fellowships up to 12months, to provide clinicians transitional funding prior to starting a higher degree.
- 2) Post-doctoral clinical fellowships up to 12 months, for clinicians undertaking research after their PhD: and
- 3) New non-clinical post-doctoral fellowships up to 36 months, for basic scientists embedded in clinical research teams.



Deadline: 2 March 2020

Funding of up to \$100k for research focused on the development of treatments and cures for mitochondrial disease. Six different types of awards are offered to fund from early career to established researchers. Applicants may be based anywhere in the world



Olivia Hodson Cancer Fund Jan2020 Funding Call

Deadline: 6 March 2020

The Olivia Hodson Cancer Fund invites applications for funding of projects starting after July 2020 and would welcome projects in CAR-T research. Project applications up to a maximum of

ERC Advanced Grant 2020 Opens: 14 May 2020

The Withdrawal Agreement between the UK and the EU has now come into force, and the UK therefore continues to participate in

programmes funded under the current 2014 to 2020 Multiannual Financial Frame-

work (MFF), which includes the remainder of Horizon 2020. Thus, researchers can still apply for ERC Advanced Grant.

The Academy of **Medical Sciences**

Starter Grants for Clinical Lecturers

Deadline: 9 March 2020

These grants provide up to £30,000 over 1-2 years for consumables, to support Clinical Lecturers who are looking to develop and strengthen their research careers.



NIH Planning Grant Program Deadline: 16 June 2020

Support for the initial development of a clinical trial or research project, e.g. establishment of research team, development of trial design, research design, finalisation of protocol etc.

Funding is for 3 years limited to \$450k. Non -US institutions must follow policies described in the NIH Grants Policy Statement



AMR/LifeArc Joint Translational Awards

Deadline: 3 March 2020

Funding of up to £250,000 to support translational research projects that seek to address a significant, unmet need for paediatric rare disease patients.

NIHR | National Institute for Health Research

Pre-Doctoral Fellowship

Deadline: April 2020

Support people who are looking to start or advance a career in health research methodology. Funding for 1-2 years, covers salary, training and development programme.

HEE/NIHR ICA Pre-doctoral Clinical Academic Fellowship

Deadline: April 2020

Master-level training for early career researchers (healthcare professionals only!) to become competitive applicants for a doctoral level research fellowship.



Discovery Research Grant Deadline: 12 March 2020

Funding of up to £200k for 3 years for research to underpin the discovery of treatments for hearing loss or tinnitus, or improve how new treatments are developed and tested.



<u>Sir Henry Wellcome Postdoctoral Fellowships</u>

Deadline: 15 April 2020

£300,000, including salary, fellowship supplement and research expenses for 4 years.

Sir Henry Dale Fellowships

Deadline: 12 May 2020

5 years funding for postdoctoral researchers who aim to become independent scientists leading their own groups.



Artificial Intelligence in Health and Care Award

Deadline: 4 March 2020 Funding aimed at accelerating the testing and eval-

uation of the most promising AI tech which meet the strategic aims of the NHS Long Term Plan. Al technologies may have a variety of applications

in health and social care, e.g. Health promotion and prevention; Diagnosis and treatment: System efficiency. The Award supports AI innovators and technologies across the spectrum of development: from concept through to initial NHS adoption and testing of the AI technology within clinical pathways.

UK Research Office confirms UK ERC eligibility for remainder of Horizon 2020

Current UK-hosted PIs on ERC grants remain eligible to hold their grants in the UK and time spent in the UK counts towards the 50% minimum working time spent in a Member State or Associated Country. All projects will be funded for their full lifetime, even if that stretches beyond 2020 (projects funded under Horizon 2020 remain Horizon 2020 projects for their full lifetime). UK institutions will be eligible to host ERC PIs for the remaining 2020 ERC Advanced Grant, but not for 2021 ERC Starting Grant, which will fall under Horizon Europe as per Withdrawal Agreement.

NIHR Great Ormond Street Hospital Biomedical Research Centre (BRC) has provided important infrastructure funding for research at the Great Ormond Street Institute of Child Health (ICH) and Great Ormond Street Hospital (GOSH), since we were first awarded BRC-status in 2007.
