Please see the response to your following request for information from Great Ormond Street Hospital for Children NHS Foundation Trust (the 'Trust').

<u>Please note</u>: The figures we have provided relate to non-exempt overseas visitors. These are charges to visitors not entitled to access NHS care in accordance to the NHS charging regulations 2015.

In your financial accounts for the financial year 2018/19 did you have a section for "losses and special payments? **Yes**

- If so how much money was accounted for in the 2018/2019 financial year as being "losses and special payments"? (Please note I am aware that the loss may have occurred many years earlier but I am interested in items which were accounted for in the last financial year, irrespective or when the loss took place.) £659k
- 2. Please detail the three largest single amounts within this total, giving a cost for each loss and a detailed description of the claim and the reason for the loss.
 - £94,380 Patient treatment costs overseas patient not entitled to NHS care
 - £50,888 Patient treatment costs overseas patient not entitled to NHS care
 - £39,413 Patient treatment costs overseas patient not entitled to NHS care
- 3. What was the biggest loss written off in 2018/19 (regardless of when the debt was accumulated) that related to an unpaid patient bill? Please state the total amount of this written off debt, the nationality of the patient and the



department of the hospital the majority where the majority of the bill was incurred. £94,380 for overseas patient, majority of bill was for intensive care; we are unable to disclose further information relating to the personal data of patients or third party individuals. Please see note below **

Please note: **Great Ormond Street Hospital for Children NHS Foundation Trust (the "Trust") is withholding information relating to the personal data of a third party individual under Section 40 (Personal Information) of the Freedom of Information Act (FOIA) 2000. The Trust is of the view that disclosing information relating to third party data would contravene the data protection principles, which could also lead to emotional distress of the individuals concerned with the expectation that their personal data would not be disclosed to FOI applicants.

The Trust also holds the view that Section 41(1) (Information provided in confidence) of the FOIA is applicable where information was obtained by the Trust, which has the necessary quality of confidence (being neither generally accessible nor trivial); and disclosure of this information to an FOI applicant would therefore give rise to an actionable breach of confidence. The information is therefore exempt from disclosure under Section 40(2) and Section 41(1) of the FOIA.
