Great Ormond Street Hospital for Children NHS Foundation Trust (the 'Trust') is a single site, specialist tertiary paediatric trust. Please see our response to your request for information below:

1. How many 'never events' have occurred at your trust over the past ten years? (please break this down by year and speciality department, and if possible also include information collected for 2020)

The Trust had 10 never events covering the last 10 years from 7 October 2011 – 17 April 2019. Please see the following table providing a breakdown for each incident:

| 08-May-14 | Syringe needle retained in patient's jaw |
| 24-Jun-16 | Misplaced NG tube |
| 04-May-17 | Spinal screw end (ears) retained in patient |
| 20-Oct-17 | Wrong tooth extraction |
| 23-Mar-18 | Retained swab in abdomen |
| 17-Apr-19 | Retained surgical instrument |
