Thank you for your request for information, which we have processed under the Freedom of Information Act 2000. Please see our response to your following request for information:

### **Your Request**

*Please tell me for the last three financial years (2016/17, 2017/18 and 2018/19) how many bills were sent to embassies following the treatment of diplomatic personnel not eligible for free UK healthcare.*

*Please break down the total for each year by a) the number of individuals billed, b) the embassies to which the bills were sent, c) the treatment given and d) the amount of the debt paid off up to the date of this email.*

*E.g. 1 bill in 2016/17 of £4,000 sent to the Peruvian embassy for a heart bypass operation, 30 percent paid off.*

*Another bill in 2016/17 of £1,200 sent to the Chinese embassy for treatment of a fractured arm, 100% paid off.*
