In an emergency our defibrillator pads act as ECG electrodes

4. *Date of Install*

The Phillips FR3 Defibrillators - Installed in 2015
The Zoll defibrillators - Installed in 2015/16 (these devices required more training)

5. *Replacement date*

Defibrillator replacements are not necessary until the manufacturers' support expires, which is approximately 2027. Both the AED and the manual devices were the new defibrillator specs for each company upon purchasing in 2015

6. *Name and email address of your Medical Device Manager within your Trust* **We do not have any staff with the job title "Medical Device Manager".**
