- 1. What swab disposal system and manufacturer is currently used in your hospital(s) etc. swabesafe sytem, bag system?*
- 2. How long have you been using your current swab disposal system?*
- 3. Are you currently or will be in near future considering switching to different swab disposal system?*
- 4. How many swab related incident (etc. unintentional retained swab) recorded in your hospital(s) over a three year period immediately before using your current swab disposal system?*
- 5. How many swab related incident (etc. unintentional retained swab) recorded in your hospital(s) over a three year period immediately after using your current swab disposal system?*
- 6. How many swab related incident (etc. unintentional retained swab) recorded in your hospital(s) from 01/01/2015 till 31/12/2019?*
- 7. How much is the cost of your current swab disposal system?*
