I'm making an FOI regarding patient group directives use within your trust. Please answer the following questions:

Great Ormond Street Hospital for Children NHS Foundation Trust (the 'Trust') has responded to your following request for information:

- 1. Does your trust have any patient group directives in use? Yes
- 2. Which drugs currently have active patient group directives?
 - Alteplase for occluded central venous access
 - Chloral Hydrate
 - Cophenylocaine for SLT
 - Intravenous Flush Heparin 10units/ml, 100units/ml and 1000units/ml
 - Intravenous Flush Sodium Chloride 0.9% and Glucose 5%
 - Iohexol GFR
 - Ophthalmology minims Cyclopentolate 0.5% and 1%, Tropicamide 0.5% and 1%, Phenylephrine 2.5%, Proxymethacain 0.5%
 - Influenza 2019 Quadrivalent influenza vaccine (Split virion)
 - Anaphylactic Reactions I.M. adrenaline 1mg/ml, hydrocortisone sodium succinate 100mg injection, chlorphenamine 10mg/ml injection, salbutamol nebuliser 2.5mg/2.5ml and 5mg/2.5ml
 - Respiratory depression Naloxone injection and Flumazenil injection
 - Ciprofloxacin in Intraperitoneal Dialysis
 - Haemodialysis Anticoagulation of extracorporeal circuits Heparin 1000units/ml and sodium chloride 0.9%
 - Haemodialysis Sodium Chloride 0.9% Priming, Washback and Hypotension
 - Heparin for Intra-peritoneal Administration Heparin 1000units/ml
 - Physioneal 35
 - Physioneal 40



- Vancomycin for Intra-peritoneal Administration
- Azithromycin and Erythromycin for Pertussis PGD
- Ciprofloxacin, Rifampicin, Ceftriaxone and Azithromycin for meningococcal disease PEP PGD

4. Are patient group directives being audited within your trust, by who and how often? Not currently being routinely audited with records within the trust, but yearly routine audits are being introduced. Our current policy states that:

"If nothing changed within a PGD, then staff who have completed required competencies do not require to be re-viewed.

If the PGD has changed, then all staff using the PGD need to be reassessed, re-complete competencies and are re-reviewed.

PGD's are audited by the Drugs and Therapeutics committee led by the lead pharmacist".
