Great Ormond Street Hospital does not undertake any research that directly involves research or safety testing on animals. However in line with UK regulations, the majority of novel medicines that are evaluated in patients at GOSH as part of our clinical research studies, will have previously been tested on animals elsewhere as part of necessary safety testing.

This would help us to continue to deliver excellence in research-led patient care for children in the future.
